## **CONTEST RULES "ILAN BLUESTONE EXPERIENCE - ÎLESONIQ"**

## 1. CONTEST RULES

**IMPORTANT:** 

PLEASE READ THESE RULES (THE "RULES") BEFORE ENTERING THE "ILAN BLUESTONE EXPERIENCE - ÎLESONIQ" CONTEST (THE "CONTEST") PRESENTED BY EVENKO G.P. ("THE ORGANIZER"). BY ENTERING THIS CONTEST, ENTRANTS CONFIRM THAT THEY MEET ALL OF THE ELIGIBILITY REQUIREMENTS SET OUT BELOW AND THAT THEY AGREE TO ABIDE BY THESE RULES WITHOUT RESTRICTION AND TO ABIDE BY ALL DECISIONS OF THE ORGANIZER, WHICH ARE FINAL IN ALL RESPECTS IN RELATION TO THE CONTEST.

### 2. CONTEST PERIOD

The Contest begins on May 11, 2022 at 12:00 PM (EST) and ends on the June 20, 2022 at 12:00 PM (EST).

# 3. ELIGIBILITY

THE CONTEST IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The Contest is open only to current legal residents of Canada and the United States who are at least the age of majority or older in their jurisdiction of primary residence as of the date of entry into the Contest.

The Contest is not open to employees of the Organizer or its advertising and promotional agencies, nor to its agents, affiliates, subsidiaries, associated companies, and their advertising and promotional agencies, nor to members of the immediate family (father, mother, brothers, sisters, and children) and to persons domiciled with any of the abovementioned excluded persons.

## 4. HOW TO PARTICIPATE

NO PURCHASE NECESSARY TO PARTICIPATE.

Entrants must have access to the Internet, which is available for free in several locations.

To enter Contest, entrants need to post on the Mixcloud platform, available at <a href="https://www.mixcloud.com/">https://www.mixcloud.com/</a>, a DJ mix they created themselves containing at least two (2) songs of Ilan Bluestone. The DJ mix should not be longer than 20 minutes (15 minutes suggested).

Posting on the Mixcloud platform is free of charge, but entrants need to agree to be bound by the terms and conditions of Mixcloud available at <a href="https://www.mixcloud.com/terms/">https://www.mixcloud.com/terms/</a>.

#### 5. PRIZE

By entering the Contest, entrants have a chance to win the following prize (the "Prize"):

- Artist access and catering the day of performance (August 5, 2022)
- Two (2) gold passes to îLESONIQ (August 5-7, 2022);
- Hotel accommodation for 3 nights at the W hotel (Aug 4-7, 2022)
- Transportation from the hotel to îLESONIQ.

The winner will also be invited on stage during the performance of Ilan Bluestone at îLESONIQ, on August 5, 2022, to perform three (3) songs.

The Prize have a total value of 1500\$ CAD.

The Prize cannot be substituted or exchanged for cash. The Prize must be accepted "AS IS", WITHOUT WARRANTY OF ANY KIND, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Replacement of Prize is permitted only at the Organizer's sole discretion. If a Prize cannot be awarded in accordance with these Rules, the Organizer reserves the discretionary right to substitute such Prize with a prize of equal or greater value.

#### 5.1 Prize Awarding:

The winner of the Contest will be selected by a jury composed of members of the Organizer and members of the Ilan Bluestone team, on the basis of their appreciation of the DJ mix submitted. This selection will be made at 1275 St-Antoine Street West, in Montreal, on the June 24, 2022 at 12:00PM (EST), among all eligible entrants. The winner will be contacted by email according to the information provided in his/her Mixcloud post. If a selected winner cannot be contacted within five (5) business days of the selection or if the Organizer determines (in its sole discretion) that a selected winner does not meet all of the Contest conditions set out in these Rules, another selection will be held, and another entrant declared the winner. This process will be repeated until an eligible winner is declared. The Prize will be sent to the winner, free of charge, at the e-mail address provided on his/her Mixcloud post.

In order to claim the Prize, the winner will be required to sign a Declaration and Release Form which will be provided to the winner electronically (and which must be returned to the Organizer no later than forty-eight [48] hours after receipt). Failure to comply with any of the above conditions will result in disqualification of any winner.

## 7. LIMITATION OF LIABILITY OF THE ORGANIZER

# 9. GENERAL CONDITIONS

- 9.1 All costs and expenses other than those expressly mentioned in the description of the Prize will be borne by the winner, namely the cost of transportation to and from Montreal, Canada.
- 9.2 All entry forms and other materials sent to the Organizer in connection with the Contest become the property of the Organizer upon submission.
- 9.3 The entry form is subject to verification by the Organizer. Any incomplete, incomprehensible, mutilated, reproduced or late entry form will be void and will not entitle the entrant to participate in the Contest.
- 9.4 The Organizer reserves the right to disqualify any person or to cancel one or more entries of any person participating in the Contest or attempting to participate in the Contest by a means that is contrary to the Rules or that is unfair to the other entrants (for example: use of automated equipment to participate in this Contest, hacking, number of entries exceeding the permitted limit, etc.). This person may be reported to the appropriate legal authorities.
- 9.5 Any attempt by an entrant or any other individual to deliberately damage the Contest site, tamper with the entry process or undermine the legitimate operation of the Contest is a violation of criminal and civil laws. Should such an attempt be made, the Organizer reserves the right to seek damages to the fullest extent permitted by applicable law.
- 9.6 For the purposes of these Rules, the entrant is the person whose contact information appears on the entry form. The Organizer reserves the right to require identification before awarding a Prize.

- 9.7 If any section of these Rules is declared or held by a court of competent jurisdiction to be illegal, unenforceable or invalid, then that section shall be deemed invalid, but all other unaffected sections shall be enforced to the fullest extent permitted by law.
- 9.8 The Organizer reserves the right, at its sole discretion, to cancel, terminate, modify or suspend, in whole or in part, the Contest at any time if an event or human intervention occurs that could alter or influence the administration, security, impartiality or conduct of the Contest as contemplated by these Rules, subject to the approval of the *Régie des alcools des courses et des jeux du Québec*, if required.
- 9.9 In the event of a discrepancy between the English and French versions of these Rules, the French version shall prevail.
- 9.10 Any litigation respecting the conduct or organization of a publicity contest may be submitted to the *Régie des alcools, des courses et des jeux du Québec* for a ruling. Any litigation respecting the awarding of a prize may be submitted to the *Régie* only for the purpose of helping the parties reach a settlement.
- 9.11 The masculine gender is used without discrimination, for conciseness purposes only.
